Register the names of other practices looking for new healthcare technology solutions. When the sale closes your referral payment will be sent to you within 90 days as long as the sale has been paid in full. This grace period allows time for the new client to make their complete payment and to ensure that they are satisfied.

Your referral payment will be equal to \$100 per practice billing provider for MEDfx practice management software, SpringCharts EHR software, or Drs Document Retrieval Solution software. For example:

For VantageRx, InstaMed and SpringScripts (standalone) referrals you will receive \$50 for each practice you refer per purchased solution.

The PrimaryData accounting department will make the referral payment by check and you can use the money as you wish.

All of our clients are eligible to participate.
